Hubbard House's pandemic response



Throughout the pandemic, the Hubbard House **Domestic Violence Hotline** and emergency shelter remained available 24/7.

You and people like you, made it all possible!

Free COVID-19 testing made regularly available to in-shelter survivors. Pandemic cleaning procedures and social distancing practices put in place, protecting survivor health.

Staff who could work remotely were outfitted to work at home, reducing inperson contact in spaces where survivors receive services and **decreasing** transmission risk, while protecting worker incomes.

Crisis Textline* developed and added to Hubbard House's Domestic Violence Hotline services, providing survivors isolated with abusers a way to reach out for help, discreetly.

Multifaceted publicity campaign launched to reach survivors with the Hotline and Textline numbers, resulting in 60⁺ media opportunities in 79 days and creating broader awareness of Hubbard House and how to access help.

Community partners, 273 of them, asked to share the Hubbard House Hotline and Textline numbers on social media and in their newsletters, allowing Hubbard House to reach new audiences with hope, help.

Online awareness campaign executed, generating more than 356,000 impressions. The 8.4% engagement rate means many survivors were encouraged to take a first step toward freedom.

In-person Stand Up & Stride Domestic Violence Awareness Walk replaced with a virtual walk. Participants shared the Hotline numbers on social media and pledged 4,250,000 steps for awareness.

Advocacy and legal appointments moved online.* With fewer barriers impeding them (transportation, childcare...), more survivors in very difficult circumstances sought services and stayed engaged.

*These service innovations, the crisis textline and virtual advocacy services, will be carried forward post-pandemic.
